

Marina H & L Membership Package Conditions Relating to Membership

The below Membership Package Conditions apply to Marina Health & Leisure, Glategny Esplanade, St Peter Port, Guernsey operated by Marina Court Investments Limited (hereinafter referred to as 'the Club').

All membership fees and other charges for services and facilities are subject to change from time to time and without notice.

1.0 Marina H & L Individual Membership Package Conditions

- a) Individual membership is available to any individual adults of age 18 years and over.
- b) The membership rate and joining fee are available on the Club website or can be obtained at Reception.
- c) Membership must be paid either monthly by direct debit (from a UK registered bank account), or annually up front and in one lump sum.
- d) Individual members may use any of the Club's facilities at any time during normal opening hours other than products and services where restrictions may apply as detailed on the Club's notice board and website from time to time.

2.0 Marina H & L Corporate Membership Package Conditions

- a) Corporate membership is available to any individual adults of age 18 years and over who are employed at a company that benefits from an official corporate scheme at the Club.
- b) Details of corporate schemes that are able to benefit from discounted membership at the club are available at Reception or can be requested by emailing info@Marina.gg.
- c) To benefit from a corporate scheme discount at the Club companies are required to have a minimum of 10 corporate paying members split across Kings Club and Marina H & L at any one time.
- d) Corporate membership extends to a spouse or partner of the corporate account holder who is residing at the same address. Reasonable evidence will be required.
- e) Periodic reviews of the Club corporate schemes are undertaken and the Club reserve the right to remove this benefit for all new and/or existing members at any time.
- f) Corporate members must provide valid proof of employment with their relevant employer.

- g) The membership rate and joining fee are available on the Club website or can be obtained at Reception.
- h) Membership must be paid either monthly by direct debit (from a UK registered bank account), or annually up front and in one lump sum.
- i) Corporate members may use any of the Club's facilities at any time during normal opening hours other than products and services where restrictions may apply as detailed on the Club's notice board and website from time to time.

3.0 Marina H & L Student Membership Package Conditions

- a) Student membership is available to any individuals aged between 18 and 22 years and who are in full time education. This package is also extended to students undertaking an official apprenticeship scheme in Guernsey.
- b) Student members must provide valid student ID upon applying for membership. Periodic reviews will be undertaken and a member may be asked to provide further copies of valid ID at any time.
- c) The membership rate and joining fee are available on the Club website or can be obtained at Reception.
- d) Membership must be paid either monthly by direct debit (from a UK registered bank account), or annually up front and in one lump son.
- e) Student members may use any of the Club's facilities at any time during normal opening hours other than products and services where restrictions may apply as detailed on the Club's notice board and website from time to time.

4.0 Marina H & L Off Peak Membership Package Conditions

- a) Off Peak membership is available to any individual adults of age 16 years and over.
- b) The membership rate and joining fee are available on the Club website or can be obtained at Reception.
- c) The hours of Off Peak entry are restricted. Details of the restricted hours can be found on the Club website or can be obtained from Reception. The Club reserves the right to change these hours without notice.
- d) Entry is only permitted outside of the restricted hours upon payment of the appropriate non-member fee(s) at that time.
- e) Membership must be paid either monthly by direct debit (from a UK registered bank account), or annually up front and in one lump sum.
- f) Membership subscription on this category is for a minimum of twelve months.

5.0 Marina H & L Short Term Membership

- a) Short Term membership is available to any individual adults of age 18 years and over.
- b) The membership rate and joining fee are available on the Club website or can be obtained at Reception.
- c) Membership must be paid up front in advance and in one lump sum.

- d) Membership is valid for the stated time period only.
- f) Short Term members may use any of the Club's facilities at any time during normal opening hours other than products and services where restrictions may apply as detailed on the Club's notice board and website from time to time.

6.0 Marina H & L Short Term Off Peak Membership

- a) Short Term Off Peak membership is available to any individual adults of age 18 years and over.
- b) The membership rate and joining fee are available on the Club website or can be obtained at Reception.
- c) The hours of Short Term Off Peak entry are restricted. Details of the restricted hours can be found on the Club website or can be obtained from Reception. The Club reserves the right to change these hours without notice.
- d) Membership must be paid up front in advance and in one lump sum.
- e) Membership is valid for the stated time period.
- f) The hours of entry are restricted. Details of the restricted hours can be found on the Club website or can be obtained from Reception. The Club reserves the right to change these hours without notice.
- g) Entry is only permitted outside of the restricted hours upon payment of the nonmember fee(s) at that time.
